 - c. sanitary sewer rehabilitation for Memorial Parkway, Sections 3, 4 and 5;
 - d. water plant no. 2 generator replacement;
 - e. Cimarron Subdivision, Sections 1, 2, and 3 and Memorial Parkway, Sections 6, 7, and 8 sanitary sewer line rehabilitation; and
 - f. update on bond application no. 9.
10. Report on West Memorial Municipal Utility District Sewage Treatment Plant meeting and proposed Plant improvements.
